Task 1: High Resolution (8-day, 10-m) LAI and Vegetation Cover Fraction for Urban Texas Completed processing of Sentinel 10-m resolution 4-band data for 2019 for Houston, Austin and San Antonio using the ESA SNAP tool to generate Leaf Area Index (LAI) and Vegetation Cover Fraction (VCF) distributions. Finished quality checking and processing the data using ARCGIS to integrate and interpolate the data. Python programs for ARCGIS procedures were created and described.

Task 2. BVOC Emitting Tree Distributions for Three Major Texas Urban Areas

Developed and applied approach for quantifying urban ecoregion distributions. Compiled and integrated urban street tree inventory data and finalized approach for quantifying tree species composition for other ecoregions. Applied approach and compared techniques for areas in Houston and Austin.
